Fourth Quarter Report:

KIDS with a Connection-ISU Extension Greene County: Serving 12 children in the fourth quarter. One new match started this quarter. Mentors and mentees were invited to participate in STEM Activity Nights. They also were given the opportunity to attend the Greene County Community Center and a gathering at the Squirrel Hollow Park for a potluck picnic and to help pick up sticks for grassy area to mowing. Several of the mentors and mentees attended the Oatts Family and Vangard Jazz Orchestra concert. Recertification application was approved by the Iowa Mentoring Partnership in May. Coordinator participated in a radio interview, attended Kiwanis, Rotary and several Community Resources Committee meetings to bring awareness about the Mentoring Program. 100% of teacher post-year surveys were completed and 90% of mentor surveys were completed and 58% of parent surveys were completed. Quarterly reports were submitted on time. Percent of funds used to date 100%.

Active Parenting- Family Resource Center: Three trainings were successfully held this fiscal year with a total of 33 participants attending number of children affected were 84. The last training was held in April 28th with 16 participants attending. Brochures had been printed and distributed to the schools, DHS office and child care providers, H.O.P.E.S and numerous agencies and business in the community. Percent of funds used to date 99. %. FTM Program- Healthy Homes: Percent of funds used to date 65.55%

New Opportunities Mentoring: Served 23 children in the four quarter, with one in process and several mentees on the waiting list. 75% of mentees showed improvement in academic performance, peer relationship and family relationship. 100% had a C average of better and no decreases. All reports were submitted on time. Percent of funds used to date is 100%

<u>Carroll County Mental Health Services</u> in the Schools-LSI: 22 children have been served. Carol Crampton bachelor level therapist, supervision by Laurie Walters. 100% of the school based referrals have had collaborative contacts occurred with all students referred for services. 100% of the case plans were delivered to referring agency that are completed, none of the case plans were delivered to the agency within the prescribed five day time period. We have struggled with complying with outcome and turnaround within five days. They will continue to work on this. 75% of

the children school performance has improved for all participating students. No trainings were done this year. But they have one already schedule for the fall of 2014 Semester. Percent of funds used to date is 41.83%.

Greene County School Intervention: 95 students served in April and May. Of these 95 students 55 were able to pass the class they were working on and receive credit towards graduation. 18 students started attending summer school in order to complete coursework of take Iowa Learning Online course. 6 students successfully completed summer school and ILO courses they were working on and achieved a total of 10 credits. Percent of funds used to date is 88.08%.

<u>Therapy Place: CFTM</u> and YDTM: 1 YDTM done in the fourth quarter. Added new facilitators, they are increasing their marketing efforts. They want to get the message out that these services are free to the consumers and are a way to avoid involvement with DHS and to assist youth with their independence in future endeavors. They meet with school personnel and with agencies in ACGG counties. Percent of funds used 9.94%.
