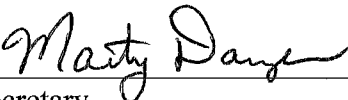


REGION 8 LOCAL ELECTED OFFICIALS

February 17, 2011

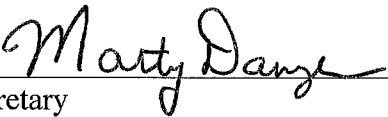
Region XII COG Board Room, Carroll, IA
