COG Seeks Houses to Acquire and Rehabilitate

The COG has been awarded funds through two different programs to enable it to acquire and completely rehab houses in the region. Once complete, the houses will be sold to income-eligible homeowners. Houses to be acquired must be vacant (e.g. on the market, in an estate, foreclosed, acquired through nuisance or delinquent taxes, etc.). Ideally, the COG is seeking properties which can be donated, either through private party or by a local government. While purchasing is an option, any purchase price paid decreases the amount available to rehabilitate the home. Homes must be feasible to repair. The COG expects updates will be needed for the roof, windows, electrical, plumbing, HVAC, and interior surfaces. These upgraded and remodeled homes will sell at market price and will include some down-payment assistance to

buyers. All proceeds realized from sales of units will be invested into additional units. Ultimately, the COG hopes to fix up 20-30 homes in the next several years. "Market forces prohibit much new construction for entry-level homeowners in our region. A key strategy of the COG for decades has been the preservation of our existing housing stock," said Karla Janning, Housing Programs Coordinator. "It is nearly impossible to replace homes we lose to deterioration and deferred maintenance. We hope to help communities across the region save single-family housing units one by one."

Solid Waste Alternative Program Deadline

The deadline for the Iowa Department of Natural Resources' (DNR) Solid Waste Alternatives Program (SWAP) is July 1, 2023. The goal of SWAP is to reduce the amount of waste generated and landfilled in Iowa. Through this competitive process, financial assistance is available for a variety of waste reduction and recycling projects.

SWAP provides financial assistance in the form of forgivable loans, zero interest loans, and three-percent interest loans. A 25% minimum cash match is required for each budget line item requesting funding assistance. Any unit of local government, business, non-profit or individual is eligible to apply for program funds.

Coon Rapids Nearing end of Downtown Facade Revitalization Project

In 2022, the City of Coon Rapids was awarded \$689,081 in COVID CDBG funds to complete facade renovations on 8 downtown buildings. Construction on the project started in October 2022 and continued throughout the winter. The project is anticipated to be completed this summer. COG staff assisted with the writing of the CDBG grant application and grant administration.

Iowa DNR Financial Resource Workshop to Help Communities Redevelop Abandoned or Contaminated Sites -Cedar Rapids - June 6, Des Moines - June 7.

The Iowa Department of Natural Resources (DNR) invites you to a free, one-day workshop, designed to introduce your community to new and expanded financial and technical resources available to help redevelop properties where environmental contamination questions about past uses of the sites, or concerns about hazardous materials, such as asbestos or lead-based paint in building materials, have hindered your community's interest in acquiring and redeveloping sites with these types of challenges, which are known as "brownfields".

The workshop will assist attendees with understanding what technical and financial assistance is available for environmental analysis at brownfield sites, redevelopment concept planning, environmental assessment and cleanup assistance, building demolition, and even building remodeling assistance, to help turn sites that community obstacles back into opportunities and assets for your community! Financial assistance available is from \$25,000 - \$5,000,000 for site cleanup and redevelopment, subject to site and program eligibility.

This workshop is targeted to local government officials, key community stakeholders, economic and community development organizations, not-for-profit entities, community groups, private citizens, and others working to promote revitalization in Iowa communities.

Presented by the Iowa DNR, the U.S. Environmental Protection Agency – Region 7 (U.S. EPA), and the Kansas State University Technical Assistance to Brownfields Program (KSU TAB), this workshop will help you:

- Understand what a brownfield is and how redevelopment can kick-start community revitalization.
- Meet your brownfield redevelopment partners at IDNR, U.S. EPA, and KSU TAB and hear about the free tools and resources they offer.
- Learn about state and federal grants, including new grants available from the November 2021 Congressional Bi-Partisan Infrastructure Law which provides a significant increase in financial resources for brownfield site assessment and cleanup.
- Learn about additional technical assistance, site analysis, and planning services that can help you meet your brownfield site and community redevelopment goals, and see examples from Iowa communities that have used these resources!

The IDNR is providing two dates and location options for you to attend the workshop. While the workshops are free, we ask that you register first, through KSU TAB. Introducing: Thriving Iowa Communities

It's no secret that housing is the start for upward economic opportunity and that families, communities and businesses will thrive when all Iowans have access to homes they can afford.

The state is estimated to need an additional 42,000 homes by 2030 to meet the demands of our robust economy. Meeting this need is going to require a strategic, proactive and innovative effort to ensure that all Iowans have the opportunity to live in the communities where they work. This is why the Iowa Finance Authority (IFA) and the Iowa Economic Development Authority (IEDA) are seeking to elevate best practices from communities that are going above and beyond to leverage innovative methods to attract housing development for their workforce.

IFA and IEDA are pleased to introduce the first of its kind, Iowa Thriving Communities designation, which will provide communities with a chance to be recognized for their efforts.

A limited number of communities will be awarded the new prestigious designation, which comes with lucrative scoring points for the Federal Housing Tax Credit and/or Workforce Housing Tax Credit programs, meaning that developers will be highly incentivized to select an Iowa Thriving Community for a proposed development through the 2024 programs. Iowa Thriving Communities will also serve as statewide community models for welcoming housing development for all Iowans.

Iowa Thriving Community applications are being accepted now through July 17.
